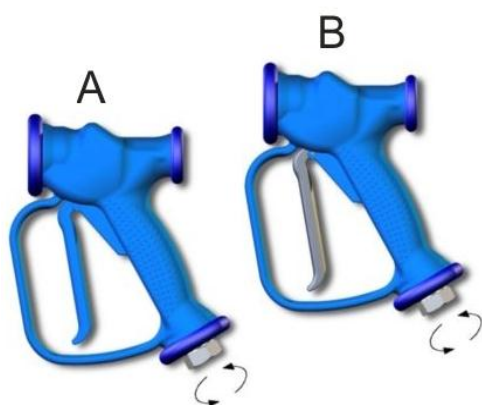

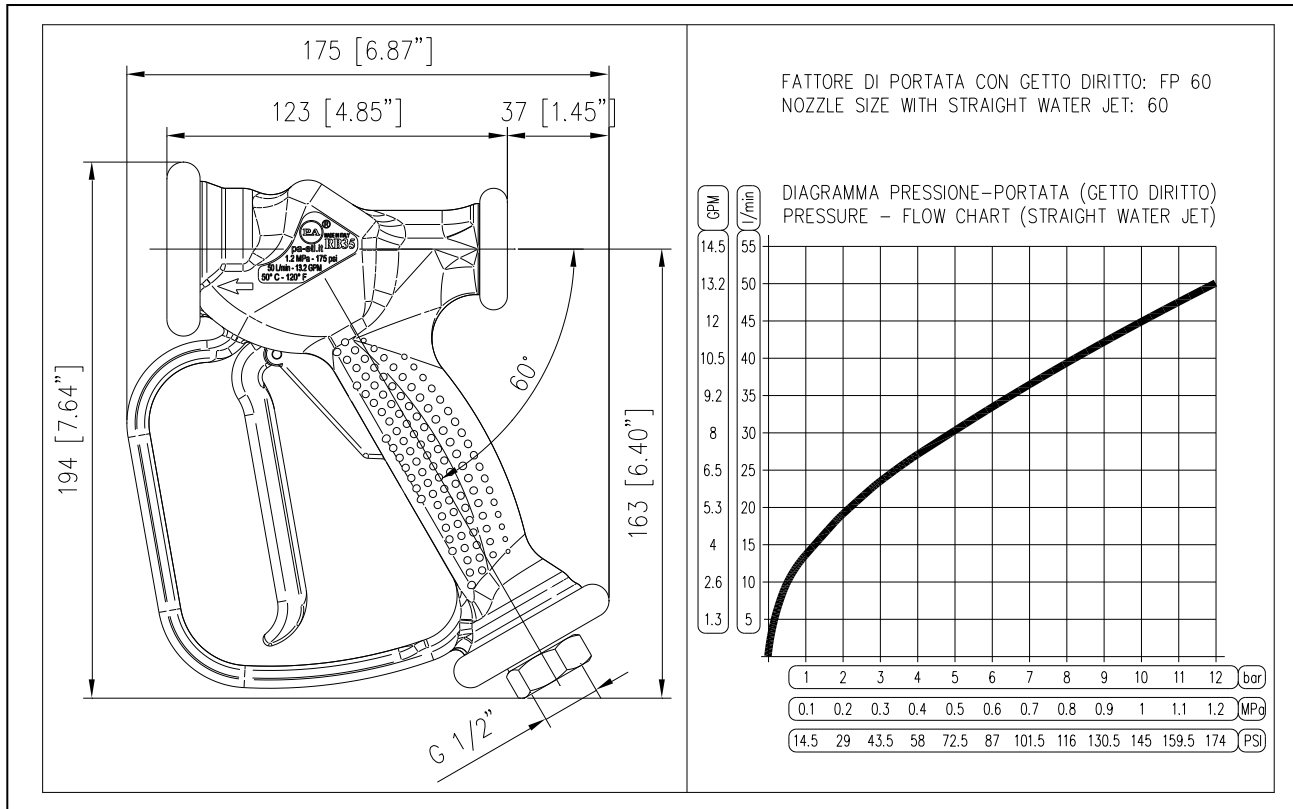

**INSTRUCTIONS**

This product is to be utilized with clean fresh water, even slightly additivated with normal detergents. For use involving different or corrosive liquids, contact the PA Technical Department. Appropriate filtration should be installed when using unclean liquids. Choose the gun in line with the working data of the machine where to be installed (system rated pressure, max flow and max temperature). In any case, the pressure of the machine should not exceed the permissible pressure imprinted on the gun.

**FUNCTION**

The gun opens and closes a duct in pressure by means of a shutter that operates on a seat in Viton or EPDM; recovery by a spring upon trigger release.

**INSTALLATION**

The gun can be used also with Hot water in compliance with the technical specs. In the system that generates hot water, it is advisable to fit equipment that will limit accidental increase of the fluid temperature.

**PROBLEMS AND SOLUTIONS**

PROBLEMS	PROBABLE CAUSE	SOLUTIONS
Leakage from the nozzle	Presence of impurities between seat and shutter. Gun seat worn out	Clean Replace seat Fit adequate filters and/or check
Leaking seals	Seals worn out	Replace seals
Difficult trigger opening	Pressure too high inside circuit.	Control and adjust the pressure if necessary.

## MAINTENANCE

STANDARD: every 400 working hours (circa 10,000 cycles), check and lubricate the seals with water resistant grease

SPECIAL: every 800 working hours (circa 20,000 cycles), check the wear of the seals and internal parts and if necessary, replace with original PA parts, taking care during installation to lubricate with water resistant grease.

Maintenance has to be carried out by specialized Technicians using only original PA spare parts.
